## Citizen's Input:

> Brad VanHoose spoke to the Board to clear the air on why he comes to the Caseyville meetings. He asked the Mayor questions concerning the payment of Village funds to the Cueto Law firm for his case during the election with George Chance, why Attorneys John Gilbert and Chris Cueto left the Village in a hurry, the \$20,000 on a forensic audit for which he offered a solution that Mayor Black resign and pay back all the money for that Audit and all the money he has been paid since he took office. He also mentions the debacle around former Police Chief Jose Alvarez, the fact the Village was granted a continuance in the Alvarez case due to the Attorney, Mr. Keck being new to the case and the fact that the Board members all want to get the Alvarez issue behind them. He went over the fact that there was collusion between Mayor Black and Bob Romanik to get rid of Mr. Alvarez as Police Chief and the fact that Mayor Black, in his haste to get rid of Mr. Alvarez, he did not follow all the Village policies. He also mentioned that if Mr. Manion is not representing the whole Village he needs to be replaced now.

When pressed by Mr. Vanhoose to answer the questions, Mayor Black responded with a no comment to each question. Mr. VanHoose ends his comments by stating he is here make sure the people know how bad the Mayor has been and how poorly Mayor Black has served Caseyville.
