DECLARATION OF EMERGENCY

WHEREAS, on January 30, 2020, the World Health Organization declared the outbreak of COVID-19 to be a public health emergency of international concern and declared worldwide pandemic on March 11, 2020; and

WHEREAS, on January 31, 2020, the U.S. Health and Human Services Secretary declared a public health emergency for the United States; and

WHEREAS, on March 9, 2020, the Governor of the State of Illinois has issued a disaster proclamation for the entire state due to the impact of the COVID-19 virus and has activated the State Emergency Operations Center; and

WHEREAS, the State Emergency Management Agency has declared a public health emergency due to the impact of the COVID-19 virus; and

WHEREAS, the Village Administration has coordinated its response with State and St. Clair County agencies; and

WHEREAS, 20 ILCS 3305/11 of the Emergency Management Agency Act and 65 ILCS 5/11-1-6 of the Illinois Municipal Code and Section 30-4-1 of the Village Revised Code of Ordinances provides certain emergency powers to the Board of Trustees and/or the Mayor; and

I, G.W. Scott, Sr., Mayor of the Village of Caseyville, and pursuant to the power granted to me by the Village Code of Ordinances and relevant state statutes, do hereby declare the existence of a local emergency in the Village of Caseyville, Illinois.


- A. Description of Emergency. The emergency is related to the COVID-19 virus which is causing or anticipated to cause widespread impacts on the health of members of the

community. I rely upon each and every matter recited in the preamble hereto, which is hereby incorporated by reference.

B. Call to Meet. Pursuant to this Declaration and Section 1-2-3 of the Village Revised Code of Ordinances, the Mayor hereby calls for a special emergency meeting of the Board of Trustees for March 24, 2020 at 7 p.m. at the Community Center within Village Hall, located at 909 S. Main Street, Caseyville, Illinois 62232.


