

**Ordinance # 2022-22**

AN ORDINANCE FOR THE TAX LEVY AND ASSESSMENT OF TAXES FOR 2022 FOR THE VILLAGE OF CASEYVILLE, ST. CLAIR COUNTY, ILLINOIS

BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Caseyville, as follows:

SECTION 1. That the amount hereinafter set forth, or so much thereof as may be authorized by law, and the same tax hereby levied upon all property subject to taxation within the municipality as that property is assessed and equalized for the current year, and the same is hereby levied for the corporate purposes of the Village of Caseyville, Illinois, to defray all necessary expenses and liabilities of Village of Caseyville, as hereinafter specified for the fiscal year commencing on the 1st day of June, 2022 and ending on the 31st day of May, 2023.

SECTION 2: The amount levied for each object and purpose is as follows:

SECTION 3: That the Village Clerk shall make and file with the County Clerk and said County of St. Clair, on or before the last Tuesday in December, a duly certified copy of this Ordinance and that the amounts levied by Section 2 of this Ordinance are required by said Village of Caseyville as aforesaid and extended upon the appropriate tax books for the fiscal year of said Village of Caseyville beginning June 1, 2022 and ending May 31, 2023.

SECTION 4: If any section, paragraph, or portion of this Ordinance is for any reason held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining sections, paragraphs or portions of this Ordinance.

SECTION 5: This Ordinance shall be in full force and effect from and after its passage, approval, and recording according to law.
