Ordinance # 2023-10

AN ORDINANCE MAKING ANNUAL APPROPRIATIONS FOR THE VILLAGE OF CASEYVILLE, ST. CLAIR COUNTY, ILLINOIS FOR THE FISCAL YEAR COMMENCING ON THE 1ST DAY OF JUNE, 2023 AND ENDING ON THE 31ST DAY OF MAY, 2024

WHEREAS, at a meeting of the Board of Trustees of the Village of Caseyville, St. Clair County, Illinois, held on this 5th day of July 2023, a motion was made, and, upon being put to vote, was passed by majority vote by all Trustees of the Village; and

WHEREAS, said motion was for the preparation and adoption of the appropriation of funds sufficient to defray the necessary expenses and liabilities of the Village of Caseyville, St. Clair County, Illinois, for the fiscal year beginning June 1, 2023, and ending May 31, 2024.

THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF CASEYVILLE OF ST. CLAIR COUNTY, ILLINOIS:

Section 1: That the following sums or so much thereof as may be authorized by law, be and the same are hereby appropriated from the taxes and other revenues of said Village, which shall be raised by taxation upon all of the real estate and personal property situated within the corporate limits of the Village of Caseyville, subject to taxation during the fiscal year beginning June 1, 2023, and ending May 31, 2024, to-wit:
