These are the written ordinances of the village I am requesting that be followed. I asked for help to stop what I thought was going to have an adverse impact on my neighborhood and my own property. And that is exactly what has happened. Some applications are submitted incomplete, missing almost everything, which by the way All information requested, a site plan and development scheduled must be provided before a hearing will be scheduled. I do not want to have to continue to bring to light that ordinances are not being followed. I am sure you are all becoming very frustrated as was apparent last night with Mr. Kaufhold. My goal providing my Citizens Input is hopes that progress would be made and not just push this trough to get it done. As I heard Mr. Kaufhold state to Sandy Allard, I just want to pass this through, we need to be done with this. Also, I want it noted we are running one company out of town for having 7 trucks in a residential neighborhood and don't seem to have an

issue with another company having the same. As stated by Trustee Abernathy on Video at the April 17th open board meeting, this is inconsistent. I have brought copies of the Application I am referring to for the new board members so that you can be fully informed to make your decision.
