Citizen's Input:

Deb Doughty of Hillwood, in Caseyville, addressed the Board on abandon houses at 624 and 628 Hill Road and the high grasses.

Mayor Scott Sr, stated that the houses were on the list to condemn.

Attorney Kaufhold, we can cut the grass and put a lien on the property before the demolition process. It is private property but we are authorized to do the minimal maintenance on it. Under the State Law we can do that. We don't like going on private property. So there is no land owner active. The most expedient cost effective way is to take it for back taxes. But that does take longer but it gives us total authority over the property. If it's middle summer we can cut the grass, and put a lien on the property for grass cutting. We usually don't get the lien money back, it goes into foreclosure.

Deb Doughty, I have called and made a complaint with Mr. Crow, that at 14 Hillwood a full tractor and equipment trailer has been in his front yard. He has been moving it around, are there any ordinances on that?

Mayor Scott Sr, Gary is on vacation this week and will be back next Monday.

Deb Doughty informed the Board that at 12 Hillwood on the side of the road there is a pile trees, and I think they are expecting the city to pick them up. The owner keeps adding to it, for over a month now and the pile is getting bigger, bigger and bigger.

Mayor Scott Sr, stated that he has not seen that, but will take a look at it.

Deb Doughty, what is going on with the Freedom of Information Act, why are we changing the things with the FOIA's?

Attorney Kaufhold, the legal is that the Board is the one that is responsible for the Village Freedom of Information Compliance Policy. They set it by ordinance and it can be changed by ordinance. Under State Statue it is the village Board that determines who and how and what conditions. If the Village Board believes there is a compliance problem, they have a right to change the process and that is what is going on here.

Deb Doughty, asked if it was getting so overwhelming with people asking for things?

Attorney Kaufhold, we have a lot of obligations under the FOIA to provide the documents but there is a certain process to do that. The County has a full-time FOIA Compliance Officer.

Deb Doughty do we have to release this, do we have to do this?

Attorney Kaufhold we do have to release public documents and there is about twenty (20) exemptions, under State Law. We are supposed to reply within five (5) days or a ten (10) day period beyond that. There are some records we are not allowed to give out, because of personal identifiable that is too sensitive. The Board is responsible for that, under State Law. So the Board sets the policy by ordinance and they can by ordinance, change it to be sure it is compliant by We have to give out documents, but we do have to make sure that they are appropriately given out.

Deb Doughty, are we charging for these?

Attorney Kaushold, we can charge minimal amounts but it never recaptures the cost. We have to comply with the process and it has got to be fully documented in a timely fashion. The Board has the obligation to do that, not anybody else. We receive a very little bit per page but that doesn't recapture the cost. The Board has to be the one in charge of that, so that is what is occurring now. The Board is making sure that ordinance is changed, so if there is any compliance issues, it will be resolved.

Deb Doughty, do police reports have to be given out too?

Chief Coppotelli, yes, under certain conditions.

Deb Doughty, that's all.

MK Dashke, informed the Board that on Saturday, June 22nd, 2019 at 10:00 a.m. till 2:00 p.m., the library will be having a Local Author Market at the Caseyville Public Library.
