The minutes for the Special Meeting on May 29th, 2019, could go on the Agenda for the June 19th, 2019 Meeting. Did mention what my notes had on FOIA's. I had nothing in my notes for a Police Vehicle." There was no audio from the Board Meeting on May 15th, I apologized for anything missed.

• Response from Trustee Buckley – "We had that meeting and we need to have that stuff done, but also there is a lot that doesn't make it into the minutes so I was not going to vote yes on it so I made a motion and if it went it went. That is why we need to have it put out on Friday so we can go through it, when they come out on 4:30 on Monday we don't have time to look at everything and correct anything. Just saying it is hard for us to read resolutions without having them."

Police - John Buckley

• Trustee Buckley deferred to Chief Coppotelli, Chief Coppotelli reported some of our cars are not up to patrol standard, we have been selling them, we transferred one car to planning and zoning that was given to us, it was brought to his attention that there was a need for a car for the fire chief so he was going to transfer another vehicle that has probably reached its life of patrol to the fire department that will leave us a little short right now, therefore is requesting the approval to purchase another car when one becomes available, there is not currently one on the state bid, this would be taken out of appropriate funds when one becomes available. There are a lot of golf carts that don't have stickers on them, just to give people a little heads up again, get this displayed again, some people that have moved in and may not know we had an ordinance on it. Work on FOIA Ordinance 11-50. Attorney Kaufhold shard a draft he had prepared with the board members. Village Board controls the FOIA so I have changed it to have the Village Board designate a Compliance Officer and process. Kaufhold repeated this is a first draft.
