Storm Water Project design is complete. Working with IDOT on the Hwy 157 intersection. Expecting to send out for bids over the winter. Expecting project to begin in spring 2020

# Village Attorney - Kevin Kaufhold

Working on next list of demolitions. Took control of one property. We are working to purchase several others from the county for back taxes. This simplifies the demolition process and saves Village resources in the long run. After demolition is complete, the Board can decide if they want to convert any of the properties to green space or a park area or sell the property.
