Police Department is actively attempting to address traffic issues to the extent there are within the control of the Department. The Police Department have limited abilities to reduce traffic congestion. Police Department applying for IDOT grants to help pay for increased patrol costs due to the interstate detour.

Public Works Superintendent - Brian Radar

Also discussed the I-255 traffic detour. Cautioned citizens to exercise patience. Completed some emergency work on the Parkdale Sewers to alleviate back-up issues. Future work planned at the site once the weather conditions allow.

Finalizing grant paperwork for \$95,000 for roadwork project on Long Street. Will need a Resolution in Support from the Board at the next regular meeting.
