A job description will be forthcoming, as not sure if this individual will require a bachelor's degree or other degrees and needs to be determined if this will come thru the Union. With a starting salary of \$20.00 an hour. They will require security clearance; this will be data driven per the Federal requirements. They will also be required to double check stops, cameras, daily logs that are being turned into State and other requirements. They will be working closely with the Federal Law, State Law and possibly the FBI.
