- Park guys are cleaning and painting at the Cemetery.
- Working on Hollywood Heights water lines.
- Working with Pam McDaniel at the Lions Park to make sure everything is set for the Christmas Light Parade.

# **Attorney Kevin Kaufhold:**

- Lots of activity on the demolitions. Handled 3 lists in 4 years. Continuing into year 5 of demos. Giving 30 days' notice and sometimes 1 in 5 homes are being rehabbed. Currently have 3 in litigation. Please contact a Board Member if you feel a home is in disarray and needs to be investigated. Sometimes homes are just abandoned, high grass, junk and not really in the demolition stage, just a cleanup is required. If the Village must go in to cut grass or clean up junk then a lien will be placed on the property. Village currently has a surplus of property they are thinking of selling. It takes \$5,000 to \$10,000 to process demolitions.
- Republic Trash Service will be implemented on 12/31/2021. Republic will be sending out letters to current customers advising of rate changes. Fliers will be sent out explaining the Trash program to all Village residents.
