Citizen's Input:

Deb Doughty – During the Cemetery meeting it was discussed to place information on the Village Website a list of Cemetery contact people. Also is it possible to recognize Bob Stephens for all his years of service to the community with a plaque. The 501C documents are ready and will be presented to Attorney Kevin Kaufhold, who advised that they would research to Reactivate 501C which is a lengthy process with IRS, nonprofit.



Pam McDaniel – Chili Dinner Saturday 11/6 from 11-6 p.m. at Fire House. Auxiliary will also be holding a Toy Sale (toys donated to Fire Department), all monies going to the Fire Department. There will also be a Toy Sale at the Fire House on Saturday, 11/13 & Sunday 11/14. December 3 & 4 will be the Mouse House at the Community Center. 11/27 is the Tree Lighting ceremony along with the Light Parade. Assistance is needed in serving hot chocolate that evening. Also, all parade participants need to be registered by 11/20 and all vehicles must be lighted.

Leonard Black – there seems to be 2 sets of standards in the Village, 1 set for me and another set for other individuals. Own property on Brookside and notice that others on the street are not taking care of their places, high grass and signs have been placed in those yards with warnings, but nothing is being done with them. Garage is caving in, cats are starting to burro and getting overpopulated. Another example is the traffic around Dairy Haven, what about that; advised that is Illinois State Jurisdiction, not the Village. Tanglewood has no sidewalks, what can be done about that; again, advised they are a separate zone and would need to discuss with the HOA representative.

- Been discussing the Motor Fuel Tax Budget
- Working on the Special Service Area (SSA) Payout
- Met regarding the Illinois Public Risk Fund Worker's Compensation

Attorney Kevin Kaufhold:

- Thanks to the Board for attending the Special Board Meeting last week, your input and participation was very valuable for a safety and zoning response.
- Police Pension Board has met with the Village on an involved basis, financial/integrity basis has been resolved.
- Litigation at the Court House is coming back up to speed since the Court House is now being able to open. Their system is now up to date with anti-hacking software. Currently have 1 case scheduled for 12/7 and 2 pending. Zoom capacity is available.
- Trash Program is still on track, have a few small issues but implementation is still scheduled from 1/1/2022. Trying to figure out who and how are thing going to get done.
