Police Chief:

- Incidents have increased in the Hotel District and have increased Patrols.
- Attempted arson 2 weeks ago at Day's Inn (laundry room) it is on tape, the individual fled, they have been identified and aggravated arson charges are pending.
- Armed robbery at Motel 6 all suspects are in custody. They are currently being held in Utah. They went on a crime spree a murder in Texas, carjacking in Georgia, California, and Utah. It will be a while before they face any charges in Illinois.
- Road crew did a Great job on the local roads Brian please thank the crew.

Superintendent of Public Works:

- Road crew has been out since 3 a.m. and currently still out. 1 Truck is down (check engine light). 4 trucks on the road to deal with the ice/sleet, which is tough.
- St. Clair County 2021 Parks Grant (\$25,000) was approved last summer. RFP to obtain bids on 2 Turf Tiger mowers. Bids will be opened on February 16 and then presented for approval by the Board.
- Planning Committee met last night regarding a Zoning Change (81st & I-64) which got approved, vacate of public right away for Tyson Project which got approved and an amendment to the Development Code regarding Front Yard Fences provided a different version. Notes to be forwarded to the Board from the Planning Commission.
- Front wall building elevation of Laundromat Engineering drawing was received from Prince so hopefully this will be taken care of as the Board had concerns on this building.

- Thanks to the Board for being in attendance this evening to vote on 2 Resolutions that required quick turn around times and needed to be voted on quickly.
