Police Chief:

- Radar system is currently on East O'Fallon Drive. Police Department will be moving it as needed in troubled areas.
- Fishing Derby is June 4, 2022. Purchased 100 Bass for Derby with FOP funds.
- Side by Side stickers are due.
- We have been issuing ordinance citations; many vehicles towed.

Superintendent of Public Works:

- We will move forward on redistricting 81st Street Business District Boundaries.
- Engineering review report has been completed for proposed storage units at 1600 N, 81st Street.
- Tyson construction halted due to Archaeological Phase 3 study.
- House at 1575 N. 81st Street demolished on Monday, April 4th.
- Relocation of water main is complete. Samples came back and we have an operating permit.
- Four Public Works employees have been attending SIUE Water Supply course for a semester and just finishing up.
- Parks Dept. seasonal employees start back on Monday, April 10th.
- We now have a lock on the dumpster at Park.
- Completing general maintenance on mowers/tractors and getting them ready for grass cutting season.

Attorney Kevin Kaufhold:

- Presentation on 2021 tax rate. 2021 rate for the Village (excluding fire) will be 2.3381 and the 2021 rate for Fire Protection will be 0.6000. We were able to raise the property tax levy dollars without increasing the Village's property tax rate due to the expiration of TIF District 3. Congratulations to the Board, Tamara and Amy.

Comptroller/Treasurer Tamara Ammann:

Village portion of the levy went down slightly. The residents that are in a different fire protection district will see a lower rate; however Caseyville Fire Department residents will see a slight increase.
 The majority of this increase is going towards our police pension. We have to be 90% funded by year 2040. Right now we are 38% funded. We are moving in the right direction. I want to thank you all for trusting me to get this done.
