- What are thoughts regarding a Nuisance Court (high grass, derelict cars, messy property) to be held here in the Board Room maybe 2 times a month Tuesday or Thursday for a few hours (late afternoon, early evening). These would be for Ordinance Violations, not criminal court. These would be for Zoning issues led by Zoning Administrator Phil Little and hire an independent Attorney (no jury). Could be handled internally which would save the Village Money. Chief Tom advised that other municipalities are currently doing this, and they seem to be working very well. Attorney Stewart will be working on the Resolution. Tony Spengler what if they don't comply; then it could become a Police Matter. Brian Eaves what is considered a derelict car; not registered, broken windows, engine parts are not in the vehicle.

#### Police:

- Additional discussion on the Homeless issue (possible resolution). Unfortunately, they cannot be arrested, as the Supreme Court has advised it is not against the law to be homeless. It is a Nationwide issue.

#### Public Works/Building:

• Due to increase traffic on Tucker, Garden Inn and Country Inn would like to give Brian permission to obtain a Consultant to do a Traffic Study. Those roads were not built for the traffic we will be seeing, so may have to rethink another entrance/exit as another 60 acres will be developed. May have to bring in State for work to 157 and County to connect into Route 50.

Need to check with homeowners to see if there is an issue with placing their yards on the website (don't put their address).
