Amy Prudent & Bobby Patel – have purchased Full Moon Building and are planning to make into a convenience/package/game business. Making sure they can obtain an on/off premises liquor license. Have parking behind building to accommodate cars. Looking to revamp front of building with arch work & glass front to see in. Currently there is no plans for building expansion. Closing date is 10/28/22 and plan to be open no later than 12/31/22.

FEMA – is looking to have 2 locations within St. Clair County to assist with Flood victims. They are currently looking into using the Village Hall and be here no more than 60 days. Days and hours are still being decided. Announcements will be made on the Village Website, Police Website, marquee, Facebook pages, possibly place on Water bills and definitely thru all 3-news media. Also, individuals from FEMA will be doing a door-to-door sweep. Currently 200 individuals have signed up with FEMA. A final decision will be made either Friday or Monday as to locations. If FEMA decides to use Village Hall, the Board Meetings will be moved to the Community Center, as the current Board Room and Conference Room will be locked with FEMA information.
