Police Chief:

- Several successful Search Warrants were pursued. One was in Tanglewood, individual was stealing construction tools and building materials. All tools and materials were recovered. During the search of the individual's home, marijuana and guns were confiscated, so we got a dangerous person off the streets. This was a joint effort with St. Clair County and Fairview Heights. Currently in St. Clair County jail with several felonies and not sure what the County or Fairview has charged the individual with. Took 1 ½ days to accomplish this arrest.
- Citizen making False Statements against the Police Department. There were never 9 injunctions against the Police, not 1 injunction against the Department. Since January the Department has handled 16,643 callouts for Assistance and of those callouts only received 13 complaints against the Officers and 9 of those were from the same family. Prior to an incident that the Board and residents heard, the Officer in question came directly to my Office to advise what transpired and he was disciplined prior to anyone knowing about the situation. I can guarantee you that No Officer is out in Public threatening our residents. I have been the Chief in Caseyville for 6 years and only twice have I requested an outside Investigation of our Department. I would like to end a quote "You are entitled to your own Opinion, You're not entitled to your own set of Facts". Hopefully this clears up a lot of the rumors, or you can always call me direct for clarification!!!

Superintendent of Public Works:

- South Main Diner has submitted Architectural Plans for review.
- Motel 6 had an Electrical Inspection and is trying to reopen by February.
- Police Department Bids 1, 2, 3 were submitted this afternoon and Bids 4, 5, 6, 7 will be submitted 10/19/2023 and opened at 2 p.m. Will provide Board members with final information.
- Street Overlay is finished, fill-in was done and now grass seeding. Boring Company hit another gas line late this afternoon, so a reminder to please call immediately if you smell gas.
- Post Office painting and installing new floors.
- Water installing water services.

Attorney Doug Stewart:

- Update Website of new Codes/Ordinances, however, have to review the Utility Tax (gas) and Board needs to decide if it is going to be 3% of 5%.
