## Citizen's Input:

## Police Chief:

- Holiday Season was very peaceful, until our 1<sup>st</sup> call. Had a car hit the Quality Inn, driver was intoxicated, happened very early around 6 a.m. Had to evacuate the Hotel due to possible gas line break. I believe the Hotel is now open except for two rooms. The suspect hit hard that there is some structural damage. Driver tried to flee, was given a DUI arrest without incident.
- Received a letter from the Collinsville Police Department thanking 3 of our Officers and the Village for the assistance at a shooting on 12/16/2023. Thanked us for offering our assistance and praising everyone's actions. The 3 Officers were Officer Woody Hall, Officer Andy Reel, Sargeant Danny Allison, this letter will be placed in their personnel file.

## Superintendent of Public Works:

- Quality Inn Had our Zoning Administrator go to inspect. Have a
  couple rooms closed, not ready for occupancy currently. Phil is also
  working with the French Village Fire Department on the sprinkler
  system to assure everything is okay for the rest of the Hotel to remain
  open.
- Planning Commission Meeting on 1/23/2024 @ 6 p.m. regarding the Red Roof Inn (Red Lion Inn & Suites), for a Special Use Permit, to serve alcohol.
- Street Tornado Siren's work. Now have 2 new sirens from the 911 Grant. They have a high pitch sound, no longer rotate, are located on every side of the pole and are voice activated. How can they be tested during the evening, sorry that is not a Village call, that is done the 1<sup>st</sup> Tuesday of every month by the 911 St. Clair County Call Center.
- Water/Sewer Repairing water mains. Repairing Fire Hydrants.
- Police Station Now have signed Packages #2 & #3, Building Shell, interior, Package #5, Plumbing and Bello mechanical has signed. Lot site work is done, fill in is one and lot of rock hauled in is almost done. Currently waiting on the drainage structures and piping, weather permitting will be installed next week or week after.
- Levee Met with the Levee Engineers regarding the levee study, coming along with the preliminary study for long term fixes.

### **Attorney Doug Stewart:**

- Levee Study The Slope and the cutting of some of the levee sides has made it difficult to navigate, so this will delay the study a bit now due to winter. The survey effort continues and the report that expected in January/February will now be delayed until late Spring, early Summer. The survey is necessary in order for the hydraulics studies. Levee study consultant has begun fund raising, he has started to set up meetings with State Representative, expect those to happy late January, early February and I encourage any of you to participate.
- 24 Reynolds demolition should be scheduled in the next few weeks.
