**Police:**

- Add to Agenda – Purchase a new Fingerprint Machine. Our current machine is 12 years old, and it has “crapped out”. No parts are available to repair due to its age. A midgrade machine would cost close to \$11,000 which would include a service contract. This includes installation (wiring) and moving to the new Police Station when needed. We are currently sending individuals to Collinsville for their assistance. This machine would also be sent directly to the State and FBI. There is also a \$1,000 yearly maintenance we can sign up for, this covers the technology of the machine, not any damage to the machine. The machine itself is \$9,339 and maintenance program are \$1795.

**Public Works/Building:**

- Reminder that the 3/19/2024 and 11/5/2024 Election will be held in the gym at St. Stephen’s Church.
