# Planning/Zoning (cont.)

• The Zoning Code needs to be investigated regarding the Gaming Flags and the Floating Beer Guy, according to our Code these are not allowed. If on right of ways they need to be removed. Understand businesses want to advertise what they provide, but most bars do have beer and gaming machines. Maybe for their Grand Openings (30 days) and then they are discarded. Possibly cite the Company who are bringing the flags into the Village (J&J) and advise the Business Owner. Also, discussed Overhead Lights on the patio areas, if they are not real bright, no flood lights or flashing lights. Discussed amending the Beer Garden and Outside Dining Codes as well.

Village needs to do any work, the Property Owner is sent a bill and then if not paid
