The Chief passed on to all Board members an email from Brad Cole, Chief Executive Officer Illinois Municipal League, regarding Regulating Public Camping within the Corporate Boundaries. I'm having Doug review to see if this would assist with our current situation as a Village. Possibly adopt, especially to assist with enforcing the relocation of individuals, and no fines for trespassing.

Planning/Zoning:
