February 19, 2025

Call to Order:

The Regular Board Meeting of the Village of Caseyville was called to order at 7:00 pm by Mayor G.W. Scott, Sr., in Council Chambers at 909 S. Main Street, Caseyville, Illinois.

The meeting opened with the Pledge of Allegiance and Moment of Silence.

Citizen's Input:

Billy Hayes – Thanks for the alarm clock, Doug, please since you aren't an elected official I have no desire to discuss with you, so please pass on to the Clerk. Mayor, 3 years ago you fired an Attorney because of all his high legal bills and then you hired his less competent associate who has even higher legal bills. Correspondence:

A letter was read from Collinsville Police Department thanking Chief Coppotelli for assigning Investigator Philip Tamburello to participate in a Major Case Squad investigation that transpired on January 21, 2025. The Team of Investigators remained committed to the cause and finally got the break they needed, eventually uncovering significant evidence and facts which resulted in the arrest of three suspects. All three were charged with First Degree Murder and several other offenses in Madison County. Investigator Tamburello and the Major Case Squad are an incredible asset to our communities. Again, thanks for allowing Philip to assist with this investigation.

Approval of Bills:

A Motion was made by Ron Sanftleben and seconded by John Buckley to pay the bills and the money drawn from the proper accounts.

Voting on Motion: - 3 Ayes - 3 Present; - Motion Passed

Police Chief:

- Kudos to the Street Department for clearing the Village Roads, which lead to very few accidents during the snowstorms. Again, great job to Brian and his Team.
- The road in front of the VFW has been blocked off on one side, the hydrant side, due to the rising of the Queen of Hearts, it will be reopened in the morning and then blocked again next week if the Queen is not revealed.
- Sargeant Allison will be presenting to the St. Clair County Mayor's regarding the Scams that have been happening in our communities. He will also be presenting to the residents at Knollwood regarding scams being done on the elderly.

Superintendent of Public Works:

- Planning/Zoning next meeting will be in regards to updating the Signage Ordinance.
- Street Department Plowed several snowstorms and all vehicles are now being maintained. We have used about 250 tons of salt so far this winter season and just ordered another 100 tons of salt.
- Water Department Doing lift station repairs. Repairing pump station on Brookside. Had 2 water main leaks. Trustee Ron will be discussing Old Caseyville Road during committee.

Attorney Doug Stewart:

- With the voting on the Grant process, we can now proceed with our applications. The Swift Grant, we really need to push the residents to apply, which would assist with either raising their homes, elevating their air conditioners, hot water heaters, etc. Once they are received, we can collaborate on the needs of the Village. Hopefully we will see some action within the next few weeks.
- Have 5 abatements that are close to their 30-day compliance, but with this cold weather I'm sure much has not transpired. Next meeting will provide to the Board for approval to move forward.
- The Village's Application for the Cemetery to become Historical has been rejected.
- Questions about the Federal freeze; what is the status of the \$30 million and the \$90 million Grants. The \$30 million is currently with the County and the \$90 million has not been provided by the Federal.

Adjournment:

A motion was made by Matt Modrovsky and seconded by Kent Luebbers to adjourn the meeting and go into the Committee Meeting.
