Police Chief:

- There was an incident last weekend involving Officer Luke Dillon during a traffic stop. As he was approaching the vehicle to remove the suspect from the vehicle, the suspect put the vehicle in reverse and struck the Officer, when in turn struck the Police vehicle and then immediately took off. Suspect has been identified, and warrants have been issued by St. Clair County Police. The car was discovered in Kirkwood, MO, however the suspect is still on the loose. Officer Dillon has minor injuries and there was some damage to the Police vehicle.
- Had a strong-arm robbery at the Huck's. A patron was playing the machines and won a substantial amount of money, the suspect grabbed the winning ticket, which can be tracked, so this was a useless crime, and the ticket was cancelled immediately. Cameras assisted with identifying the suspect and warrants were issued and the suspect is currently in custody.
- Reminder that golf carts and side-by-side stickers are available. Also, animal tags are available when pets get lost, and someone brings them to the Police Station. These tags assist the Police with tracking down the owners.
- Good luck to everyone for the Queen of Hearts.

Superintendent of Public Works:

- Park restrooms will be opened on April 1. Placed an ad on the website for hiring of seasonal workers, which are usually return employees, high school students, college students, but whoever wants to provide an application, we will review.
- Street & Water Departments Doing emergency sewer repairs along with a contractor, which will cost from\$15,000-\$20,000. Thought it was a sinkhole, but ended up being the main, so hired a contractor to do the project and we are assisting him with this project.
- Levee Grant received a notice from the Grant Department, they had 3 to 4 questions to be answered, the Village Attorney, Consultant and I will be meeting to provide a response.
- Storms Friday night had the Street Crews out that evening and Saturday.
- Water Department checked on all the water pumps and doing brush removal.
- During the storms the railroad trestle got clogged on the north side. I contacted the Railroad and within 2 minutes I received a call back that they would remove the debris by midweek. However, within 24 hours it was done. At 10 a.m. this morning the Railroad notified me that they had removed the center part of the Railroad Trestle. That is great news for our Village, and it was a great Team effort by all. Everyone played a part in getting this accomplished.

Attorney Doug Stewart:

- Regarding the railroad, I have been at the State House with regards to the Levee conversations and revising the Grant paperwork. The areas being discussed/covered for this project are 157 to 255, still a big problem from 255 to the river. SIUE has a budgetary line to do all the necessary leg work to design and research for the Spring Lake Project and at this time have no idea how much money has been designated but will know more once the May budgets have been approved. They are planning to work with Engineering and Public Health Students. They have dedicated a team of professors and students to handle this big regional project.
- Demo/abatement activity will be provided during Committee.
